After the call, I sat for a minute. My mind gone numb. Tears blurring my vision. How could this be? We all knew that Tony had been ill, but we all knew Tony and knew he would bounce back. Tony dying was not even in the realm of possibilities in my mind. Tony was strong and tough and would eventually be back. Sadly, that is not going to be the outcome.

Just a quick remembrance. Back in the late eighties, when I was working as a carrier at Willow Glen, the station was a frightful mess. Tony arranged a meeting with some carriers and the station manager plus the Director of City Delivery. Well, with Tony at my side, I told them just what I thought was wrong with the station and how relations could be improved. The City Delivery Director really wasn't interested in my input. So much so that he told me I should be looking for a new job. That I was not fit to work in his Postal Service. Tony and I rolled our eyes at each other. Later, we laughed, and Tony said he would 'help' me find a new job. In 2001, I retired from the Postal Service. The last I heard of that City Delivery Director was that he had been shipped off to somewhere in southern Arizona. I always knew that with Tony's

support, you could speak your mind at the Post Office and survive. Just about every month in the Branch minutes, I would write Tony's credo: work safely and professional, eight hours work for eight hours pay. That's Tony's way and that's the way to survive thirty years and retire.

The only reason I can see that Tony was taken from us is that there must be some labor disputes Upstairs. With Tony and Howard up there, the angels will have no problem getting a contract. Rest In Peace, My friend.

Some Personal Thoughts on Tony

I have known Tony Cortese since 1978 when Vera and I transferred from Westgate Station to Hillview because the commute was only 5 minutes, and we were less likely to be late (a strategy that still wasn't 100% effective).

Although I have known Tony for nearly 30 years, I know very little of his personal life. My impression, reaffirmed by those who knew

him best, was that he deeply loved his wife and family – the center of his life. Outside of a circle of close friends and family, Tony was a private man, who, ironically, was deeply committed to the union and the letter carrier. This, I believe, can be no better illustrated than the way he handled his illness of the past several months that ultimately led to his untimely passing. At first, most of the stewards in our local knew nothing of his illness. Those who did know

he swore to secrecy. Later, when he attended the board meeting in November and then hosted the Christmas party a couple of weeks later, he appeared weak, but, because of his outward optimism, many of us assumed that he was recovering. It's my belief that he didn't want to burden the membership with his

personal suffering.

He had route 1113 in 1978. It was a nice route, and I wondered how it was possible. He learned early out that you have several basic responsibilities to yourself and the Postal Service: 1. Do an honest day's work for honest day's pay. 2. Always perform your job in a safe manner. 3. Always follow your supervisor's instructions and, if you disagree with

the instruction, file a grievance (Tony was never afraid to and always encouraged his file a grievance stewards to do so when it was appropriate). 4. The carrier on the route is ultimately responsible for the nature of his/her route. Tony had a nice

route, but he wasn't on it for long because, within a couple of years, he became President of NALC Branch 193 – a position he was to hold for the next 27 years. He gave up his route to serve the membership and continued to serve in a *full-time capacity* for many years after retirement from the Postal Service.

Establishing those relationships was one of Tony's greatest attributes. He never took comments or opinions personally (unless his personal integrity was questioned in which case he could be quite intimidating). In fact, he seemed to have an extraordinary talent of judging a person's character. Despite

strong differences of opinion on union manners with some local leaders, he would appoint or recommend to the National Business Agent's office, those very leaders if he believed they could best serve the membership with their personal skills, knowledge, or enthusiasm – whether it was as an member of a joint safety committee or a coordinator of some special program or a liaison to a member of the U.S. Congress.

There should be no doubt whatsoever in anyone's mind that if it came down between the Postal Service and the NALC, Tony would was come down on the side of the union every time, but there was more to it



than that. Although he knew the local and National Agreement and local by-laws governing the branch, he would often appear to cut corners to get results, to the chagrin of many of us who often questioned

his methods and, at times, the results regarding disposition of a grievance. Certainly he would utilize those legal tools needed in arguing a case, but he was successful more often than not because the supervisor or manager with whom he was talking knew that Tony still respected him/her as a


person. A settlement was possible without any personal animosity. His good working relationship with PM Sammy Vasquez benefited carriers. At the informal memorial at

our regular union meeting (Valentine's Day), Sammy described how he would meet with Tony and that they would talk about their grandchildren. After several minutes, Tony would tell to him about a young mother having problems on probation and ask if him could arrange her transferred to a different station for a second chance. Maybe the carrier who after years of struggling and nearing retirement could be reassigned a less stressful position outside carrying mail because of safety issues. Sammy would make it happen with a phone call because he knew and trusted Tony's

judgment and that Tony respected him. Ultimately, relationships were more important than the technical aspect of some particular

manual or formal agreement.

Vera and I first became actively involved with the union after attending a board meeting – I didn't even know what it was – but I was hooked because I saw that this was where the action was. This was where decisions were made, and the most current and important information discussed, and I knew I needed


to be a part of this. As a steward for the past several years, and I've

been able to see first hand how effective Tony was in assuring the well-being of the members and the interests of individuals facing severe action from management.



There is a saying that you can catch more flies with an ounce of honey than with a gallon of gall. Essentially, one is more likely to reach an agreement with someone

with whom he(she) disagrees if he treats that person with respect and dignity. It's a question of establishing good personal relationships with people that you are dealing and negotiating with.







Under Tony's watch, we have the WIN process that replaced the hostile and punitive "Letter of Warning". We have a joint safety committee (Union members appointed by Tony) that actively monitors street observations in a corrective, non-disciplinary manner – unique to San Jose. We purchased and own outright our branch office

building, renting out several office spaces. This in-

come has enabled our branch to return part of our dues to all our members with \$60 gift certificates during the Holiday Season. We have a dental plan (Union Dental), unique and, by far, the best offered anywhere, covering up to 90% of some costs. We have annual picnics, branch BBQ, retirement dinner, and Christmas Party, at little or no cost to its members. Retirees receive checks (in many cases, of several hundred dollars) presented to the carrier from the Branch president, on his/her last work day

that reflects the number of years the carrier was a dues-paying member of Branch 193. This is a partial list. Different mem-

bers may have been initiated some of these benefits by, but they occurred on Tony's watch. In my opinion, he deserves most of the credit.

Of all the events that Tony hosted probably


the single most important to him personally was the annual Retirement Dinner, where the retirees of the past year are honored. Retirees had a special place in Tony's heart for many of them had begun their postal careers prior to 1970-71 at the time that the working conditions in the Post Office (before the Postal Service was established) were horrendous. There were no health benefits, no guaranteed hours (mandatory split shifts), no cost-of-living, and no binding arbitration. The situation was so desperate that it drove carriers in from coast-to-coast to an illegal wildcat strike


> ganization legislation that finally led to the benefits that we enjoy and take for granted today. Tony and the "oldtimers" were there. Because he has honored them, over the years, several of them have honored him with their support and loyalty. Virtually all of our entire board of officers outside the stewards and a few of the trust-





My sorrow and mourning of the passing of your leader and my friend Tony Cortese is great. His heart literally went out to his family, his union family his colleagues and many friends and there are eternally grateful to have enjoyed his presence. He was a gentle giant with love for family, his job, and for always putting people first. His legacy is solid as oak and his heart as good as gold. He made me proud to be a union member...many times. Thank you for your years of supporting him.

I met Tony at Post Office orientation over 26 years ago. I was from another Branch but that made no difference. He inspired me to look up my shop steward, sign up for the NALC Health plan and I

became a union member while on probation. I couldn't wait to join the NALC after listening to Tony! He lit a passion that still burns warmly.

We met again at training in the Italian Letterman Hall. (Isn't it ironic to meet in a building that reflects his heritage and our occupation!) where he hosted numerous trainings for the Business Agents under Brain Ferris, Bill and Tom Young and Dale Hart. He was a compassionate and passionate host who made sure we were comfortable and ate well! Thank you Tony!



Tony and I shared a love/hate relationship to politics. We understood the importance of educating and involving members in influencing elected officials. Your branch had one of the most successful political action funds for years and was ahead of other branches in the nation. Who else would have distinguished

leaders like Presidential Candidates John Kerry, Michael Dukakis and most local Congressional Representatives including former cabinet member Norm Mineta, and Congressional Representatives Don

Edwards, Zoe Lofgren and Mike Honda as well as a list of local officials. He knew befriending local officials might eventually benefit Letter Carriers if they get to Washington, DC.

Zoë and Mike are prime examples of his political insight. Hi bipartisan support of Tom Campbell assured Letter Carriers had an important advocate in the GOP for Hatch Act reform. Letter carriers today can more successfully participate and influence our political agenda free from retaliation. Thanks again Tony!

We were allies in the Employee Involvement Process, an important break though in USPS Labor Relations from 1986 to 1996. Tony told me early on "Bottom"

line is you are here for the members," and I never forgot it. Together we had a strategy for eliminating insulting, demeaning, and costly ineffective Letters of Warning going into personnel files. Even today the LOW's are not the initial stage of discipline. Tony convinced management that it was a win-win. We used to chuckle about the award he got for the Friends program as it saved thousands in retrenchment cost to the Postal Service and helped save the jobs of countless new employees.




He would chuckle how management gave him an award for his ability to save money and saving member jobs during probation periods. He guided the program through many successes despite the lack of support by the managers. Thanks Tony!.

Tony watched out for us. He would step in where others had given up on people. Some one may be going through some of life's serious problems. The bureaucratic postal system advocated removal when a worker faced the trauma of divorce, finance, drug and alcohol concerns, or physical, emotional, or mental challenges. Tony's

compassion would tell stewards "We're here to help people and get them help ...we don't just write them off..." Later they would turn their lives around. Thanks to you Tony.

How did Branch 193 members get free dental benefits for years at no cost? Tony was no frivolous spender but NALC 193 was the first local in the




Bay area to quit paying rent and buy a building. He was able to leverage the revenues initially to get free dental care to the member. Even today Branch 193 is the only large Bay local charging the minimum dues! Thanks again Tony! And how about the FOOD! Branch 193 always ate well. The candidate's nights, the retiree's dinners, the EI trainings, the meetings, the branch barbeques and the food drives. Speaking of the food drive, Branch 193 hosted a citywide food drive in San Jose back in 1990. The following year Tony volunteered to


be one of ten pilot sites in the NALC food drive. Your success assured that the entire nation would follow your example. To-

that family comes first. I struggled and tried to change my plane ticket so I couldbe at the February Branch meeting to


pay my respects. But true to form, when I spoke with Danny, he told me, "Patty, you know what Tony would tell you - family comes first". Danny went on to














Our Friend

When Tony got the autographs for his grandson, he was so happy, he beamed with a smile from ear to ear. I joked with Tony saying how'd you like to feed one of those linemen at your dinner table. He laughed and chuckled.

When Tony had time after union business, he talked about his grandchildren, Austin and Ashley. He cherished his grandchildren. He took them to conventions, ballgames and anything that was fun. He wanted them to enjoy life. He told me one year, he bought his grandson Austin a huge batting cage to help

him improve his hitting in little league! I thought, wow, what a grandpa! Then about a year later, he told me how well Austin was doing be-

cause of the batting cage and he made the All-stars! I could see he was a happy and proud papa. I asked him if he could adopt my kids as his grandchildren too, he laughed. Tony's grandchil-

At the union BBQ's Tony would always he the one to hand out the



NALC Branch 193 Howard Quackenbush Scholarship

Eligibility Criteria:

Applicant must be son, daughter, grandchild or legally adopted child of an active, retired or deceased letter carrier. Stepchildren are eligible if they live with the member in a regular parent-child relationship. The applicant's parent or grandparent must be a member in good standing of the NALC at least one year prior to December 31, 2006.

Requirements:

Category I - Applicant must be in grade 12 of high school, have an SAT score of 900 or above and a 2.75 grade point average or above in their secondary school. Grade transcripts and a copy of the original printout of SAT scores must be mailed with the application.

have a 2.75 grade point average or above, commencing with grade 13. Grade transcripts must be mailed with the application.

All category I and II applications must be postmarked on or before March 31, 2007

Regulations:

The scholarship is to be used toward pursuing an undergraduate degree at an accredited college of the recipient's choice. Winners may accept other college scholarship assistance in addition to the Branch 193

Category II - Applicant must be in grade 13 or above and award. If the winner suffers certified serious illness, the scholarship will be held in abeyance for not more than one year.

Method of selection:

Eight \$1,000 scholarships will be awarded at the April 2007 branch meeting. Four names from Category I and four names from Category II will be drawn at random.

Terms of award:

A check in the amount of \$1,000 will be given to the winners after proof of entrance is given to Branch 193.

Proposed Language:

ARTICLE 4 BRANCH OFFICERS
